INSTRUCTIONS

- 1. The person completing this application must be the owner of the ATV/UTV.
- 2. All fields are required, and the application must be signed by the owner, Incomplete applications will be returned.
- 3. Include a check or money order for the required amount. (\$5.00 yearly for permit) TO: Muncy Township
- 4. If applying for multiple passes, include a separate and complete application for each ATV/UTV. One check or money order in the appropriate total amount is acceptable.

PERMIT RULES AND CONDITIONS

- 1. Helmet- All riders must wear DOT approved helmets per 67 Pa. Code Chapter 107 (relating to motorcycle helmets)
- 2. Driver's License Required for ALL Operators- Required on all Muncy Township Roads. Possession of a valid PA Driver's License or the equivalent out of state operators' license by an individual operating an ATV/UTV is required.
- 3. Lights and safety devices- All machines operated upon Muncy Township Roads must have functional headlights and taillights which are always visible for a minimum distance of 500 feet. Hand signals will be used if the vehicle is not equipped with turn signals.
- 4. Speed Limits- unless otherwise posted, the speed limit for ATV/UTV on Muncy Township Roads will be 25 MPH.
- 5. Day Light Operation Only- ATV/UTV operators can operate within Muncy Township Roads during daylight hours only, sunrise to sunset.
- 6. Valid Registration and insurance cards on the machines at all times.
- 7. Muncy Township tag (decal) must be visibly displayed on all ATV/UTV on Muncy Township Roads.
- 8. Operators must carry the Muncy Township permit upon issuance at all times while riding ATV/UTV on Muncy Township Roads.
- 9. It is unlawful to operate an ATV on STATE ROADS. It is the operator's responsibility to know what routes, routes are lawful ATV/UTV use.
- 10. PERMIT REVOCATION: Muncy Township permits may be revoked by Muncy Township at its discretion for violations of permit conditions; violation ATV/UTV laws; verified instances of unsafe operation on township roads, trespass upon private lands, at the request of local or state police.
- 11. PA ATV/UTV Law Observance: Operators must know and obey all requirements of the PA ATV/UTV law and are subject to the enforcement of the law.
- 12. TRAFFIC COBTROL DEVICES: ATV/UTV operators must follow all traffic control devices on Muncy Township Roads.

OPERATOR ETIQUETTE

- 1. Travel Responsibly: Stay on designated roads. Operate at safe speed. Travel with a partner. It is unlawful in the state of Pennsylvania to operate ATV/UTV while under the influence of alcohol or a controlled substance.
- 2. Respect the rights of others; Be considerate and learn roadway etiquette. Do not trespass. Proceed with caution around bikers, horses, walkers. Keep speed low around others. Keep noise and dust down.
- 3. Educate yourself: tell others your plan. Check the weather forecast, wear safety gear. Know your limitations, time, and fuel. Take ATV/UTV safety course.
- 4. Do not disturb wildlife.
- 5. Do Your Part: Pick up litter.
